Position Focus

Provides technical support for Environmental Health and Safety in the areas of biological, chemical, radiological and environmental survey/sampling and physical safety.

Essential Duties

- 1. Assist with environmental monitoring of campus water sources.
- 2. Participate in asbestos evaluation program.
- 3. Perform routine biological, chemical, and radiological surveys/sampling for University and regulatory compliance.
- 4. Receive, monitor and deliver radioactive material packages to authorized laboratories.
- 5. Coordinate with laboratories and Physical Plant to ensure that emergency showers and eye washes are inspected and certified.
- 6. Inspect and certify chemical fume hoods, or other engineering controls.
- 7. Assist with investigation of odor or other indoor air quality complaints.
- 8. Assist with facility inspections for physical safety, security and compliance issues.
- 9. Compile inventories for laboratory and non-laboratory areas (including chemical, biological, radiation or other potentially hazardous materials).
- 10. Perform routine respiratory fit tests.
- 11. Assist laboratories in proper hazardous waste management.
- 12. Perform data entry and reporting functions for various applications and databases.
- 13. Perform periodic instrument calibration.
- 14. Assist in mitigation of hazardous materials incidents.
- 15. May perform other duties as assigned.

Required Education and Experience

- 1. Two years of related work experience in the same job family and a Bachelor's degree in a related field; or four years of related work experience in the same job family and an Associate's degree in a related field.
- 2. Working knowledge of chemistry, biology, physics, and physical safety.
